## 01 COLLECTION

*At Klösterligasse 4 in Zofingen, during the auction and the after-sale period that follows.*

- Collection and payment within **14 days** of the auction's close. Items are handed over **unpacked**.
- Payment on site: **cash in CHF or debit (EC) card**. Credit cards and cheques are not accepted — for bank transfers or credit card payments, see our separate *Payment Information* sheet.
- Items are released only once payment has been received in full.
- Items not collected within this period are stored at the buyer's expense (min. **CHF 2.– per day and item**).
- For multiple lots or large objects we recommend arranging an appointment to avoid waiting times.

## 02 IN-HOUSE SHIPPING / PACKAGING

*For many objects we handle packing and shipping ourselves. Simply ask by e-mail, quoting your **Bieternummer**.*

- On request we can also just pack the item; you then arrange collection through your own shipping partner.
- For items that are too fragile or too large, in-house shipping is not possible; our transport partners below can help.

## 04 VAT & CUSTOMS

*Buyer's premium of 23 % on the hammer price, plus 8.1 % VAT on the premium and on our services.*

- **Export refund:** with an export declaration stamped by Swiss customs within **30 days** of the auction, the VAT is refunded, provided the tax amount per invoice exceeds **CHF 80.–**.
- **International shipments:** customs duties and import taxes in the destination country are entirely at the recipient's expense. The customs regulations of the destination country apply.
